Award for Excellence in Herpetofaunal Conservation
Nomination Information

About the Award: This Award is presented annually by Northeast Partners in Amphibian and Reptile Conservation (NEPARC) to recognize an individual who has made significant contributions to the conservation of amphibians and reptiles in the northeast region of PARC. The award recognizes someone who has worked collaboratively with partners outside the individual's organization to prevent loss of species or their habitats, or who has educated others in furtherance of the PARC mission.

NEPARC is committed to PARC's Core Value of Inclusivity and Collaboration (<https://parcplace.org/>), including a strategic goal of enhancing inclusion and equity within the herpetofaunal conservation community. In addition to the criteria described above, nominees will be evaluated on their promotion of diversity, equity, and inclusivity in the field of herpetofaunal conservation.

The recipient is presented with the award at the Annual Meeting of NEPARC, which is typically held each July or August. Recipients are awarded registration and free lodging and meals for this meeting, as well as a plaque commemorating the award. By accepting the award, the award recipient commits to abiding by the NEPARC Meeting Code of Conduct.

Award Criteria:

Nominees may be submitted by third parties or self-submitted. The criteria for consideration are as follows:

1. The candidate upholds PARC's Code of Ethics by observing the highest standards of scientific integrity and professional behavior.
2. The candidate has displayed exemplary commitment to building or strengthening partnerships, particularly with stakeholders outside the individual's organization or with non-traditional stakeholders that further the mission of NEPARC.
3. The candidate demonstrates a commitment to increasing diversity and advancing the inclusion of under-represented groups of people in herpetofaunal conservation through their perspective, experience or active contributions to the field.
4. Special consideration will be given to any person who has exhibited tenacious effort, leadership and professionalism in a manner that is inspiring to their peers, and who has been overlooked by other means of recognition. Current members of the NEPARC Steering Committee are not eligible for nomination.

Nominations:

A call for nominations is made prior to the annual meeting by NEPARC Steering Committee co-chairs, and information about the award is distributed, including the attached nomination form. Steering Committee members review nominations and conduct an anonymous vote to select a recipient. The award will only be given out during years in which at least one qualified applicant is nominated, but a maximum of one award per year will be given.

Supplemental information may be a brief biographical sketch or letter of recommendation that illustrates the nominee's long-term efforts, leadership and professionalism. (Please limit to two pages total.)
